	<ul style="list-style-type: none"> <li>- Instructional staff is defined as: Administration, Classroom and Related Arts teachers (including itinerants), OT/PT, Speech, ESE Inclusion/ELL Resource, Psychologist, ESE Program Specialist, Reading Coach, Counselor, and Media Specialist.</li> <li>- Non-Instructional staff is defined as: Office Manager, Office Staff, Classroom and General Assistants, Facility Manager, Food Service Manager, SACC Director, and ELL Tutor.</li> <li>- Staff who meet the criteria, are no longer at Corkscrew, but are currently employed by CCPS, are eligible to receive A+ compensation.</li> </ul> <p>Other Stipulations:</p> <ul style="list-style-type: none"> <li>- SST will be eligible for a bonus of .19 share</li> <li>- Ballots will remain anonymous</li> <li>- If the reserve is not needed within 1 year, funds left over will be used for non-recurring classroom instructional materials divided equally among all grade levels as approved by SAC.</li> </ul> <p>Reserve: 1 share</p> <p>Motion to Approve: Elizabeth Barley          Motion to Second: Joshua Drysdale          SAC Vote: 7 yeas/ 0 nays          Time: 4:34 pm          Total votes: 105</p> <ul style="list-style-type: none"> <li>- 63= proposal 1</li> <li>- 12= proposal 2</li> <li>- 30=proposal 3</li> </ul>
