

# Fees

SACC services are self-sustaining through parent fees. The fee schedule for SACC services are uniform throughout the District. Fees are approved by the District School Board of Collier County.

Annual Enrollment Fee (REQUIRED)	\$75 per family
WEEKLY FEE	
Before and after school	\$90 per child
After school only (4-5 days)	\$75 per child
After school part-time (2-3 days)	\$56 per child
After school (1 day only)	\$30 per child
Before school only	\$25 per child
Early Dismissal	\$28 per child
Full-day Enrichment Program (Non-student contact days)	\$30 per child

Acceptable payment methods include: Tuition Express Automated Payments (voided check or credit card—Visa, Master Card, Discover), money order, or cashier's check. **No cash accepted.**

## About Us

Collier County Public Schools' School Age Child Care (SACC) services are offered both before and after school on elementary school campuses. This ensures that the school's learning and core academic standards are connected to activities in after school services.

### STAFF / STUDENT RATIOS

**Kindergarten – 5<sup>th</sup> grade:** One adult for every 20 children.

SACC services offer enrichment learning opportunities that are different from, but connected to, those during the school day.

### ACTIVITIES MAY INCLUDE

- Academic Tutoring
- Homework Assistance
- Reading & Literacy
- Supervised Free Play
- STEAM
- Arts/Drama
- Organized Sports and Games
- Physical Fitness Activities
- Music and Dance

## Hours of Operation

Services are provided every day that school is in regular session. Services may be offered on non-student contact days (teacher planning days, winter break, spring break, and observed holidays).

- **Before School Services:** 6:30 a.m. - 7:45 a.m.
- **After School Services:** 2:45 p.m. - 6:30 p.m.
- **Early Dismissal Day:** 11:45 a.m. - 6:30 p.m.
- **Full Day Services:** (no school/no students) 6:30 a.m. - 6:30 p.m.

SACC services conclude promptly at 6:30 p.m. We encourage parents/guardians to make every effort to pick up his or her child on time.

## Information

### ELIGIBILITY

Children must be enrolled in an elementary school within Collier County Public Schools or any of the District sanctioned Charter schools to be eligible for services provided by SACC.

**Age requirements:** A child who is at least five years of age by September 1st and who is attending kindergarten through grade 5. All elementary children may attend through the summer following his/her last year in elementary school.

### MEDICAL — ILLNESS — EMERGENCIES

SACC services encourages daily medication to be taken in the school clinic during the school day prior to arrival. If a child becomes ill while attending after school services, the parent/guardian will be contacted to pick up the child. I understand that EMS (911) will be called when there is an emergency requiring evaluation and/or transport of a child for medical treatment, and I will assume responsibility for payment for EMS services. The Site Supervisor/Designee will contact the parent/guardian. If unable to reach a parent/guardian, one of the emergency contacts listed on the Emergency Contact and Emergency Form will be contacted to pick up and/or care for the child.

### SNACKS

During after school and full-day schedules, a daily nutritional snack will be provided for your child. Please notify staff of any food allergies upon enrollment. Full-day services: All lunches/snacks brought from home must be properly packed in a lunch box or cooler. All lunch boxes or coolers should be labeled with child's name. Heating or refrigeration for any lunch items is NOT available.

### NO SCHOOL DAYS FOR STUDENTS

On Teacher planning days, winter break, spring break, and observed holidays, parents/guardians must provide lunch and one snack each day. During these breaks, children may attend full-day services at his or her school, if offered.

### SAFETY

Maintaining the safety of children is the number one priority of SACC services. Your child will be under the supervision of qualified personnel familiar with his/her school. Parents/Guardians are responsible for sign-in and sign-out of his/her child to the designated area. Children are released ONLY to authorized persons listed on the enrollment form filed with the SACC services. Special instructions pertaining to a child's care should be given in writing to the Site Supervisor/Designee. Please see additional COVID-19 Guidelines.

### SCHOOL CLOSURE

When schools are closed due to weather, disaster, pandemic or other safety related concerns, SACC services will be closed.

### STUDENT CONDUCT/DISCIPLINE

Discipline shall be consistent with the standards outlined in the Collier County Public School Code of Student Conduct and the school's discipline policy. Please review and adhere to the Collier County Public Schools District Student Conduct Policy 5500.
