AGENDA ITEM 4

**SIP Goals for PME**

Dr. Rebecca Merhar discussed the SIP Goals (School Improvement Goals). This is a statewide document that is submitted to the state, based on the previous year FSA data.

The instructional and non-instructional staff collaborate to create action steps to achieve optimal educational success for students. The focus is on students who fall within the lower percentiles, targeting each student depending on their achievement levels. Teachers review the data to evaluate what areas need to be reviewed and/or revised. There is also a Connect for Success Committee at each grade level that meets monthly.

**Goal #1:** By June 1st as determined by FY22 FSA results, the Low 25% ELA student gains will increase by 3% (50%-53%) by participating in daily targeted instruction to include fluid small group instruction during the DI block with strategic scheduling for support staff to push in, MTSS Tiered Intervention instruction, administer iReady Diagnostic and district quarter benchmark assessments

**Goal #2:** By June 1st as determined by FY22 FSA results, the Low 25% Math student gains will increase by at least 3% (58%-61%) by participating in daily targeted instruction to include fluid small group instruction during the DI block two days per week with strategic scheduling for support staff to push in, MTSS Tiered Intervention instruction, Waggle (K-3) and ALEKS (4-5) progress reports, and district quarter benchmark assessments.
